- 3. ELECTRICAL EQUIPMENT:** Any exhibitor intending to bring electrical equipment to the showground will be required to ensure that such equipment is fitted with earth leakage circuit breakers and that all electrical leads, tills and appliances have been inspected and tagged by a licensed electrical contractor.
- 4. CONFLICT OF PRODUCT:** No Exhibitor is permitted to sell products in conflict to normal lines as sold by Showman's Guild or Nimbin A & I Society Inc.
- 5. NO GLASS ALLOWED;**
- 6. PAYMENT:** payment for stall fees will be required BEFORE the dates of the show. EFT details will be provided once application is confirmed accepted;
- 7. AGREEMENT:** by submitting this application I agree to all of the terms herein, and acknowledge that any exhibitor who does not comply may be asked to leave the grounds and / or be denied permission to exhibit. The Committee's decision is final.
